## Service Agreement

The Parties Herein Agree As Follows:

- 1) *Kitten Sittin'* / Cat Sitter agrees to provide the services stated in this contract in a reliable, caring, and trustworthy manner. In consideration of these services and as an express condition thereof, the Client expressly waives and relinquishes any and all claims against said *Kitten Sittin'* / Cat Sitter except those arising from negligence or willful misconduct on the part of *Kitten Sittin'* / Cat Sitter.
- 2) Cost per visit will be calculated using the attached *Kitten Sittin'* Fees Sheet. These prices are periodically subject to change.
- 3) Per this Service Agreement, Client understands that:
  - Full payment is due on the first day of a scheduled Care Visit.
  - All returned checks will be charged a \$30 handling fee.
  - Our cancellation policy: With less than one week's notice, client will be charged \$30.
- 4) In the event of natural disaster, *Kitten Sittin'* / Cat Sitter is entrusted to use best judgment in caring for cat(s) and home. *Kitten Sittin'* / Cat Sitter will be held harmless for consequences related to such decisions.
- 5) In the event of personal emergency or illness of *Kitten Sittin'* / Cat Sitter, Client authorizes *Kitten Sittin'* / Cat Sitter to arrange for another qualified person to fulfill responsibilities as set forth in this contract. Client will be notified in such a case.
- 6) For health and safety purposes *Kitten Sittin'* / Cat Sitter strongly recommends that Client's cat(s) are visited at least once a day. *Kitten Sittin'* / Cat Sitter will schedule every-other-day visits however, with the clear understanding that, if *Kitten Sittin'* / Cat Sitter believes a cat's health or safety to be at risk, Client shall allow *Kitten Sittin'* / Cat Sitter to complete the visits on a daily basis. Should this situation arise Client would first be notified of cat's health / safety status. In this event Client shall reimburse *Kitten Sittin'* for the additional visits required.
- 7) *Kitten Sittin'* / Cat Sitter will consider administration of medicines on a case-by-case basis. If this duty is accepted *Kitten Sittin'* / Cat Sitter will not be held responsible should the cat have an adverse reaction to, or refuse administration of, any medication(s). Should the cat(s) develop any negative reaction to medication(s) *Kitten Sittin'* / Cat Sitter will do everything possible to remedy the situation (including taking the cat to your Vet or the nearest Veterinary 24-hour Clinic).
- 8) In the event that *Kitten Sittin'* / Cat Sitter is required to employ a locksmith to gain entry into Client's premises (due to a malfunction of the lock, or a failure of the Client to leave a key) it shall be the responsibility of the Client to reimburse all costs incurred. Therefore, to protect their cat's health and safety, Client expressly gives *Kitten Sittin'* / Cat Sitter the authority to employ a locksmith, on Client's behalf, in the event of the aforementioned occurrences.
- 9) Should *Kitten Sittin'* / Cat Sitter be bitten, or otherwise exposed to any disease or ailment received from Client's animal (which has not been properly or currently vaccinated), it will be the Client's responsibility to pay all medical costs and damages incurred.
- 10) *Kitten Sittin'* / Cat Sitter will provide the utmost care in watching both your cat(s) and your home. However, due to the extreme unpredictability of animals, *Kitten Sittin'* / Cat Sitter cannot accept responsibility for any mishaps of an extraordinary or unusual nature (examples: biting, furniture damage, accidental death, etc.).

11) Kitten Sittin' / Cat Sitter reserves the right to terminate this contract at any time before, or during its term, if Kitten Sittin' / Cat Sitter, in its sole discretion, determines that a danger exists to the health or safety of Kitten Sittin' / Cat Sitter. If these concerns should prohibit Kitten Sittin' / Cat Sitter from effectively caring for cat(s), Client authorizes that the cat(s) be placed in a kennel, with all costs being charged to Client.

12) Client authorizes this signed contract to be valid approval for future services of any purpose provided by this contract permitting Kitten Sittin' / Cat Sitter to accept telephone reservations for service and enter premises without additional signed contracts or written authorization. Client shall be responsible for notifying Kitten Sittin' / Cat Sitter of any relevant revisions or updates that should be made to the Client / Pet information records on file.
